PUBLIC HEARING FOR A WAIVER OR MODIFICATION OF 105 ILCS 18-8.05 (F) (2) (i) TO ADMINISTER THE ACT PLUS WRITING EXAM ON MARCH 3, 2015

Dr. Riggle explained that this hearing is a necessary step in the process of submitting a waiver application that was explained to the Board on December 15.

Dr. Riggle opened the public hearing for a waiver or modification of 105 ILCS 18-8.05 (F) (2) (i) to administer the ACT Plus writing exam on March 3, 2015.

After three calls he declared the hearing closed.

In response to a board member's questions the administration explained:

- Changes in instructional times and testing.
- The expected next steps and possible options depending on the State's response to the waiver.

Dr. Riggle congratulated Dr. Wegley on his new role as superintendent of District 30. Dr. Riggle thanked District 30 for expediting their decision which allowed us to advertise the principal position.

Dr. Riggle and Mr. Swanson reviewed the timeline for the GBS principal search.

Dr. Riggle stated that the GBN search process is well underway, but the administration felt that it is important that we take advantage of the pool of candidates being screened and developed by Ray and Associates for both positions.

A Board member asked to see the profiles generated from Ray and Associates.

In response to board member questions, Mr. Swanson reviewed the candidate interview process.

In response to a Board member's question Dr. Riggle stated that most likely Board members would be able to interview finalists the week of February 9th. A special meeting would be called if there is a majority of a quorum that wanted to be in attendance.

The administration and a board member discussed the possible length of the new principals' contracts.

DISCUSSION/ACTION: REVISED RAY AND ASSOCIATES AGREEMENT FOR PRINCIPAL SEARCH

Dr. Riggle stated that the original agreement with Ray and Associates for the GBN Principal Search process was \$12,000 plus expenses. A revised agreement was requested to replicate services to include the GBS Principal Search. The revised agreement reflects a cost of \$20,000 plus expenses to complete both processes. Dr. Riggle asked the Board to approve the change to the agreement.
