## **Curriculum Reports: Scope and Sequence**

The administration reminded the Board of the new curriculum improvement process explained at the last board meeting.

The following departments I.S.'s outlined their focus, successes, challenges, and next steps: GBS and GBN CTE, GBN English, GBS Fine Arts, GBS World Language, and GBS and GBN Physical Education.

In response to board members' questions, the administration:

- Noted that this is an evolving annual process
- Explained the process and continuum of curriculum work
- Stated that teachers and students are excited about the growth in career pathways
- Discussed the connection between the CTE department and college counselor; shared that we are looking at new tools, programs, and/or systems that will help with the State mandate for Career Pathways
- Shared that this is an opportunity for our students to explore different career opportunities and post-secondary options
- Discussed different assessments the students are provided to try to find their path or passion
- Explained the learning gaps during the pandemic and areas of focus
- Shared different strategies we use to help all students grow
- Noted that we identify student's individual needs and provide them with the best resources
- Discussed how students can continue their artistic skills in their life, and career; the skills taught in Fine Arts are skills needed in life
- Shared how gaps in language courses are handled and resources that are available to help students
- Noted the most popular World Language classes are; Spanish, French, and American Sign Language which is quickly growing
- Explained the State of Illinois currently does not have a language graduation requirement, but the law is changing and will require two years of a language for graduation
- Shared how nutrition is threaded through the P.E. curriculum and how the courses that were reviewed are tailored to meet student needs depending on the sport they participate in

## **School Operating Budgets for Fiscal Year 2023-24**

The administration:

- Explained the purpose of the school operating budget is to provide for the operational needs of each school
- Recommended that based on the increasing cost of goods and services the administration is recommending an increase of 3%
- Explained the accounting adjustment that was done last year and did not need to be repeated this year
- Stated this item will come back on the consent agenda at the next board meeting

In response to board members' questions, the administration:

- Confirmed that the District enrollment is slightly decreasing based on our enrollment forecast
- An average of 75-80% of our budget is salaries
- Noted that the operating budget is part of the larger budget
- Stated that there are some capital projects (furniture) that would be funded with the school operating budgets, but the overall construction is now part of the district capital projects

# **School Improvement Late Arrival Days**

#### The administration:

- Recommended an increase in late arrival days from 14 to 22
- Explained the purpose is to provide time for professional development, work on school improvement goals, and improve the quality of the time used for these purposes
- Stated that the following stakeholders were part of the decision-making process: Cabinet, GEA representatives, Instructional Leadership and Building Administrative teams, faculty, and parents
- Noted that there is a 140-minute impact on classroom instructional time across the school year
- Stated the focus is on student well-being and faculty collaboration
- Noted we will have a revised bell schedule and a consistent day of the week (Wed)
- No action is necessary, just a consensus

In response to board members' questions, the administration:

- Stated that there will not be any extracurricular activities or early bird classes during this time
- Stated that our building will be open 30 40 minutes before the class starts, and there will be some parts of the building where students can come earlier
- Board provided consensus

# New Board Policy 6700 - Abused and Neglected Child Reporting

The administration:

- Stated that to be in compliance with Erin's law the Policy Committee recommended this new policy
- Explained the policy confirms mandated reporting responsibilities, required training, and investigation guidelines
- Noted that this is the first reading of the policy and any suggested changes or revisions will be brought back on consent at the February 27, 2023 board meeting.
