**Re:** Overnight Student Trip for Glenbrook Symphony Orchestra and Glenbrook South Jazz Ensemble

to Participate in a New York City Performance Experience

### **Recommendation**

It is recommended that the Board of Education authorize the overnight trip for Glenbrook Symphony Orchestra and Glenbrook South Jazz Ensemble participate in a performance experience in New York from Sunday, March 26, 2023 through Friday, March 31, 2023 in New York City.

### **Background**

Board Policy 7230 authorizes student trips that offer valuable experiences for students outside the school district's boundaries. The policy was recently revised in February 2022 to define conditions and parameters based on the type of trip and the consideration process for all requests. The principal first approves all day and overnight trips, and any trip requiring an overnight stay must also be approved by the superintendent and the Board of Education.

Before being presented to the Board for consideration, the Associate Principal for Administrative Services works with the Business Services department to ensure that each trip proposal adheres to all conditions and parameters defined in Board Policy. This includes, but is not limited to:

- Classification of the trip;
- Determination of the approval process;
- Determination of financial responsibility and the process for collecting fees (if applicable);
- Travel insurance coverage (if applicable);
- Collection of a permission slip and verification of accident and health insurance coverage (if applicable);
- Lodging, meals, and transportation arrangements; and
- Registration requirements.

Earlier this month, we received a request from Mr. Aaron Kaplan, Ms. Rachel Atlas, Mr. Brian Boron, and Mr. Nick Krejci requesting approval for Glenbrook North and Glenbrook South students that are part of the Glenbrook Symphony Orchestra, and Glenbrook South Jazz Ensemble students to participate in a performance experience in New York City from Sunday, March 26, 2023 through Friday, March 31, 2023. During this experience, students will offer two concert performances, participate in a workshop where students will learn music to a Broadway show and get to work with a real Broadway conductor, participate in two concerts, tours of Radio City Music Hall, Carnegie Hall, Rockefeller Center, Lincoln Center, NBC Studios, and visit many common New York sites.

A detailed overview of the trip is provided in the attached materials. Additionally, a summary of the trip's conditions and parameters is provided in Table 1.

Dear Dr. Williamson & Mr. Markey,

The Glenbrook Symphony Orchestra and Glenbrook South Jazz Ensembles are proposing a trip to New York City between March 26<sup>th</sup> – March 31<sup>st</sup>, 2023 coinciding with the spring break week for District 225. The groups would perform four times at local venues and workshops, which would enhance the 2022-2023 GSO and Jazz curricular repertoire. The proposed itinerary is very exciting: a performance by the New York Philharmonic, two different Broadway performances, a "Broadway-in-the-Classroom" workshop where students will learn music to a Broadway show and get to work with a real Broadway conductor and Broadway singers, tours of Radio City Music Hall, Carnegie Hall, Rockefeller Center, Lincoln Center, NBC Studios, and visits to the 9/11 Memorial, Central Park, Museum of Modern Art, Ellis and Liberty Islands, and more. This trip is a great opportunity to cultivate the next generation of performing artists and music consumers. New York City is the arts capital of the world, and it exposes our students to a city overflowing with different musical performances, functions and styles.

The Glenbrook Symphony Orchestra and Glenbrook South Jazz program have a long-standing history of traveling together, dating back over 40 years to the late 1980s and further strengthened by the GSO/GBS Jazz Welsh exchange program in the 2000s. We do our best to avoid music groups traveling on the same year, in particular orchestra and band because of the number of shared students between both ensembles and between North and South. Since both the Glenbrook North Band and Glenbrook South Band programs have typically traveled as marching band ensembles on the opposite year, the GBS Jazz band travels only as a jazz ensemble with GSO. The two parent organizations, GSO Parents Association and the GBS Instrumental League, also do the majority of fundraising opportunities together.

### **Performance Opportunities**

The performance experiences on the trip are excellent opportunities for our students to make music in a city that runs on the performing arts. For the GSO, performing at St. Paul the Apostle Church on their concert series for traveling instrumental ensembles is wonderful because students get to play in the heart of Manhattan for a music-loving crowd, and in a space with incredible natural acoustics. For the jazz band, performing live music at the jazz supper club



Swing 46 gives the students a real-world experience playing swing music for customers who not only enjoy the music with their meal, but also on the dance floor. There will be a third performance opportunity for both ensembles at either Grand Central Station or the Statue of Liberty where the students will be able to perform for both locals and tourists at an iconic New York City landmark. Finally, both the orchestra and jazz band students participate together in the "Broadway in the Classroom" workshop where they get two hours to learn and rehearse a piece of Broadway music with a Broadway conductor and then get to have Broadway actors sing the song with them. Getting to work with these professional theatre musicians is an unforgettable experience that cannot be replicated in any other city. Students will also have the opportunity to see three live performances: a concert with the New York Philharmonic, along with a talkback with some of the musicians following the concert, as well as two Broadway performances.

### Quotes

Three quotes from three different travel companies were gathered for the trip proposal. Based on the trip quotes, we recommend <u>Guardian Travel Group</u> due to their pricing, level of service offered for the trip to New York City, and their travel insurance covering 100% of the trip for a group cancellation. Attached is a proposed itinerary and a summary of inclusions. Two additional quotes from the other travel companies have also been included on pages 26-38 of this packet.

### **Travel Insurance**

In the event that a student contracts Covid-19 on the trip, that student would be quarantined in the hotel and under the supervision of one of the chaperones. If a student contracts Covid-19 leading up to the trip, Guardian's travel insurance plan for an individual cancellation refunds up to 80% to the family, which is significantly better than 3<sup>rd</sup> party Cancel-For-Any-Reason (CFAR) plans. More details on their Trip Protection Plan can be found on page 24 of this packet.

### Cost Breakdown

The trip will occur during the Spring Break of 2023; the students would not be missing any school for the trip. The cost of the trip will be approximately \$2200.00 to \$2400.00 per student for the week. Transportation, security, housing, most meals, and all gratuities are included. The hotels in consideration offer a triple option for the one-per-bed policy. Below is a table of projected trip costs based on the number of fully paid participants. For 150 people on the trip, the breakdown would be approximately 130 students, 15 chaperones (including a medical professional), and 5 staff members.

### **Cost Allocation Explanation**

Based on the functionality of the cost allocation spreadsheet, there are a few sections that require clarification.

### **Staff Expenses**

- The 5 staff members we are requesting go on the trip include the 4 music teachers (Aaron Kaplan, Rachel Atlas, Brian Boron, Nick Krejci) and 1 administrator (Mark Maranto).
- These 5 director packages are built into the cost of the trip.

### Student Expenses

• There is currently \$785 per student under "Registration" – this is the approximate amount for everything else included in the trip that is not meals, transportation, and lodging. This amount covers all performances (2 Broadway shows, New York Philharmonic performance), entrance fees to all activities such as Ellis Island and Rockefeller Center, luggage/instrument fees, and all other aspects of the trip, as laid out in the Summary of Inclusions page of the quote from Guardian Travel Group. This would also include transportation by bus between Glenbrook South to O'Hare for our departure and arrival.

## Travel Protection

Because most airline tickets issued for group travel are nonrefundable, purchasing travel protection to protect oneself against unforeseeable events that may impact travel plans is highly recommended for tour members. Through the plan administrator **Trip Mate**, MCI has several travel protection plans available for tour members to purchase. These plans help protect tour members from situations such as *Trip Cancellation*, *Trip Interruption*, *Travel Delay*, or *Emergency Medical Expenses*. Music Celebrations International provides enrollment forms for travel protection to all tour directors or tour coordinators to distribute to tour members.

### WHAT TRAVEL PROTECTION COVERS

- Trip Cancellation and Trip Interruption provide coverage for cancellation or interruption of a trip due to reasons such as injury, illness or death suffered by the insured or a member of the insured's immediate family.
- Emergency Medical Expense covers reasonable medical costs if emergency medical treatment is required while on the trip. Tour members are encouraged to check their current health insurance to see if it covers international travel.
- Baggage Protection provides coverage for loss, damage or theft of baggage and personal belongings. Tour members are encouraged to check to see if they are covered for baggage loss under their homeowner's policy.
- CFAR/Cancel For Any Reason gives tour members the option to cancel their tour for any reason up to 48 hours prior to the scheduled departure date and be reimbursed 75% of the nonrefundable costs paid for their trip. ### TRAVEL PROTECTION FAQ (Prepared by Trip Mate)

### What is CFAR? What does CFAR cover?

CFAR stands for "cancel for any reason." With CFAR tour members can cancel for any reason that is not a covered reason for Trip Cancellation by filing a claim for 75% of their *non-recoverable* investment. The request for cancellation must be received by MCI's office in writing up to 2 days prior to the tour's scheduled departure date.



### Are doctors available on call through the travel protection plans?

Our standard and premier plans include multi-lingual medical professionals available 24 hours a day to provide help, advice, and referrals for medical emergencies. They can help you locate local physicians, dentists, or medical facilities, and provide services for:

- Medical Consultation & Monitoring
- Medical Evacuation Arrangements
- Emergency Medical Payments
- Prescription Assistance
- Repatriation of Remains Arrangement
- 24-Hour Legal Assistance

- Language Interpretation Services
- Emergency Cash Transfer

### What is considered to be a covered quarantine?

"Quarantine" is a strict medical isolation imposed by a recognized government authority, their authorized deputies, a medical examiner or a physician to prevent the spread of a disease. An order is not considered to impose a strict medical isolation unless the order requires the relevant person to be confined twenty-four hours per day, seven days a week throughout its duration.

### What happens if a tour member needs to quarantine on tour?

Our premier plan includes Travel Delay coverage with a benefit of up to \$2,800 total (\$200/day). If a tour member contracts the Coronavirus and needs to be quarantined (as defined above), Travel Delay provides coverage for additional expenses for reasonable accommodations, meal and local transportation expenses.

### Is there a deadline for purchasing the premier plan?

Tour members can purchase travel protection up until 60 days prior to departure (all payments and documents need to be received by MCI no later than 60 days prior to departure).

Will a cancellation be covered by the Standard Coverage if a tour member has to cancel prior to departure? Only if the tour member is canceling for a covered reason as outlined in the plan documents. The Standard Plan has a very limited amount of coverage (\$600 of the tour cost). Purchasing the Premier Plan with "Cancel for Any Reason" (CFAR) is the best way for tour members to protect their investment.

### Is CFAR/Cancel For Any Reason available to tour members from all 50 states?

Tour members from all US states, except New York, are eligible to file a claim under CFAR/Cancel For Any Reason.

### If a tour member is a resident of the state of New York: is it worth it for them to buy upgraded travel protection if they cannot get CFAR/Cancel For Any Reason coverage?

Yes, it is worth it to buy the upgraded protection. Even without CFAR/Cancel For Any Reason coverage, tour members will still be eligible for the \$200 a day/\$2800 total Travel Delay benefit (which includes certain coverages during quarantine, as noted above), as well as multiple other benefits.

## If a tour member lives in any state (other than New York), do they have a choice as to whether they buy the upgraded plan with CFAR or without CFAR?

Yes, tour members have a choice to either buy the upgraded plan with CFAR or without CFAR. Trip Mate highly recommends all eligible tour members to buy the upgraded plan with the CFAR coverage.



### Here's a hypothetical scenario of what may happen if your tour gets canceled due to a pandemic:

Let's say your tour cost is \$4,000, and weeks (or days) prior to departure, the tour is canceled. After working with vendors and partners, MCI is able to secure an 80% refund (20% nonrecoverable). You would get a refund of \$3,200 from MCI. If you have purchased the premier plan upgraded insurance, you can then file a claim with Trip Mate to receive 75% of the \$800 that was nonrecoverable. Out of that \$800, you would get \$600 refunded from Trip Mate. Of the entire investment, the total loss is \$200 plus the cost of the insurance premium.

### What if an individual decides not to travel, but the group is moving forward?

If an individual decides not to travel but the group is moving ahead, you will follow MCI's cancellation penalty structure for your group. Whatever the non-recoverable amount adds up to is what the individual tour member would file their claim for with Trip Mate. The individual can receive full reimbursement of their non-recoverable tour expenses if their reason for cancelling their tour is covered under the Trip Cancellation coverage. If the individual's reason for cancelling their tour is not covered under the Trip Cancellation coverage, they can receive 75% reimbursement of non-recoverable tour expenses, provided they have purchased the upgraded plan with CFAR/ Cancel For Any Reason coverage.

### Where can tour members go for questions about the travel protection plans?

MCI can help with questions on pricing related to travel protection. However, if tour members have any coverage questions, they can reach out to the travel protection plan administrator, Trip Mate.
