Re: Public Hearing: Tentative Budget for Fiscal Year 2019-20

Background

Each year the Business Services department is charged with the task of developing a budget in tentative form, to be presented and discussed with the Finance Committee and Board of Education. The fiscal year 2019-20 tentative budget and supporting materials were presented to the Finance Committee on Tuesday, July 23, 2019, and to the Board of Education on Monday, July 29, 2019.

In accordance with the Illinois School Code (105 ILCS 5/17-1), the tentative budget shall be made available to public inspection for at least 30 days prior to adoption. Additionally, the Board of Education shall hold a public hearing prior to adoption of the budget. To fulfill these requirements the following activities have been completed:

- **Fiscal Year 2019-20 Tentative Budget Made Available to Public Inspection**
The tentative budget document was made available to the public through the District's website, and was also available in print for at the District Administration Building. The document was made available on Tuesday, July 30, 2019.
- **Publish Notice of Fiscal Year 2019-20 Tentative Budget Availability and the Public Hearing**
Notice of the public hearing, and the availability of the fiscal year 2019-20 tentative budget was published in The Glenview Lantern and The Northbrook Tower newspapers on Thursday, August 1, 2019.
- **Public Hearing on the Adoption of the Fiscal Year 2019-20 Budget**
A public hearing on the adoption of the fiscal year 2019-20 budget has been scheduled as part of the Monday, September 9, 2019 Board of Education meeting.

A final budget for the fiscal year 2019-20 will then be presented to the Finance Committee on Tuesday, September 17, 2019, and to the Board of Education at the Monday, September 23, 2019 meeting for consideration.
