Public Hearing: Tentative Budget for Fiscal Year 2018

Dr. Riggle declared the public hearing on the budget for Fiscal year 2017-2018 open at approximately 7:19 p.m. and asked if there was anyone from the public who wished to comment.

No members of the public commented on the budget.

Dr. Riggle declared the public hearing closed after asking for public comment three times at approximately 7:20 p.m.

- Dr. Riggle stated recent legislation was passed by the state:
 - Evidence-Based funding for Student Success Act

- Budget Implementation Act
- Budget Appropriations Act

Dr. Gravel presented the impact of the recent legislation:

- Core of the evidence-based funding formula
 - Provide financial support from the State's budget to support the education of all students in PreK-12 schools
 - Provide a stable, sustainable school funding system that strives to get all Districts to adequate funding over time
- Glenbrook's Adequacy Level
 - Variables will be considered including; cost of 27 essential elements and local capacity
 - ISBE is in the process of calculating adequacy levels
- FY 2018 State Funding Assumptions
- FY 2018 Corporate Personal Property Replacement Tax Assumptions (CPPRT)
- New Reporting Requirements
 - Annual Spending Plan will need to be submitted as part of the annual budget process, ISBE has not yet identified the requirements
 - School Report Card will include; final % of adequacy, local capacity target, real receipts
 - Increased reporting requirements within ISBE's Employment Information System (EIS)
- Voter Initiated Referendum to Lower Tax Levy
 - Allows 10% of voters in school district to petition for a referendum to reduce taxes for educational purposes up to 10%
 - Referendum can only be considered in odd number years at the consolidated election in April
 - If the referendum fails, it may not be repeated until after two future consolidated elections (effectively, once every 6 years)
- Mandate Reliefs
 - Districts can determine the frequency of physical education as long as it is a minimum of 3 days per 5-day week
 - Districts are permitted to contract with a third-party to provide driver education services
 - Provided through more streamlined waiver processes

In response to board members' questions, the administration explained:

- How this would affect the money we are supposed to receive and outstanding payments to the district
- The effect on the budget
- State monies are approximately 4% of tentative budget
- The estimate of monies we are expected to receive is very conservative and based on past trends
- The administration believes we will meet tentative budget assumptions on monies expected to be received
- Adequacy is based on quantitative information with consideration on regional factors

- The district does not have to reduce the level of excellence at the Glenbrooks because of state adequacy expectations
- How the legislation will impact the district's reserves
- The legislation is an additional democratic check on the system
- Local school boards will still have control over what is an adequate education
- The legislation was a response to the local property freeze
- The pension system funding is not addressed by this bill
- The detailed information provided in the tentative budget is a tool to share the financial information on the Glenbrook story
- The next step will be to review physical education and driver education programs and policies
- The district is currently staffed to do more than the minimum of 3 days of physical education
- Over the last six months the district has collected data on what monies the district has historically received so that we can plan and prepare next year's tentative budget
