# Discussion/Action: Goals and Initiatives

The administration:

- Noted that our goals and initiatives have taken on a more strategic planning process model
- Provided an update on:
  - School climate data and the feedback gathering and analysis process
  - The work in progress in communications including "The Glenbrooks" publication, weekly updates, website, thought exchange partnership plan and human interest stories and social media work
  - Student wellness work including administering the first SEL assessment, working on future professional developent, fine tuning the intervention module, and reviewing SEL resources
  - Teaching and learning initiatives including a new curriculum improvement cycle underway, science classroom prototypes being tested and PowerSchool Special Programs IEP system implementation, ongoing professional development and attendance and discipline policies under review with a student success focus
  - Leadership and develpment efforts including a kick-off to the principal preparation cohort, licensed administrators job analysis and salary study, highly qualified substitute staff recruitment, and bargaining contract agreements
  - Facilities and Finance projects including a negotiated agreement for the 2023 health insurance plan year, completed a "clean" 2021-2022 fiscal year

audit, prepared bid specifications for summer of 2023 capital projects, developed a 10-year exterior door replacement program, identifying options for installing solar panels, comprehensive assessment of building automation system, finalized updating all policies and procedures for Fiscal Management and Business Management, working to replace the fleet of 15-passenger activity buses, finalizing phase 2 of classroom initiatives, completed a cyber self-assessment, working on upgrading our 2-way radio systems and piloting new digital clocks and messaging systems

- The website dashboard on our goals and initiatives
- Noted that as we continue with these with goal and initiatives we plan on being more inclusive as we develop these along with our strategic plannining process
- No action is necessary

In response to board members' questions, the administration:

- Explained what parents of students who have Individualized Education Plans (IEP's) will be able to see in PowerSchool Special Programs module
- Noted our attendance application is not part of PowerSchool and we are working on possible improvements to parent access on a phone
- Will provide more snapshots of different systems at a future meeting
- Shared that the communications department is trying to manage the amount of communication to parents
- Provided clarification on our substitute system (Red Rover)
- Discussed the 15-passenger bus lease which will be part of the projects for the next budget
- Outlined at a high-level two solutions suggested by our cyber self-assessment prepared by SSCRMP's risk management partner, Marsh
- Commented that we will have a presention from our College and Career Counselors at a future board meeting
- Provided clarification on district data points from the SEL survey and the different categories
- Noted that tuition reimbursement per our contract for the principal cohort and explained the process and qualifications to be eligible
- Will bring information regarding the diversity of staff numbers in the cohort
- Shared that we do have students who do their student teaching here at the Glenbrooks and we do have contracts with multiple schools to send us student teachers
- Discussed the recruiting process
- Noted that we still have permanent substitutes and a report will come to the Board in the Spring
- Provided clarification on some of our cyber security systems
- Explained how the goals and initiatives are being shared and developed with all stakeholders and their engagement
- Shared the process for transportation for the next fiscal year, noted that analysis done on transportation shared that it was not beneficial to bring transportation in house; the district is analyzing the benefits of increasing smaller vehichles for in house use

### Discussion/Action: Class of 2027 Chromebook Purchase

The administration:

- Recommended the purchase of the Lenovo 500e Chromebooks with the Google Chrome Management License at a cost of \$540,615
- Noted there is a unit cost reduction from last year
- This will come back on the consent agenda item at the next meeting
