Background Data

The Property Tax Limitation Act (PTELA) requires the County Clerk to proportionally reduce the levy of each fund subject to the Act in the event a District exceeds the tax cap limitation. The County Clerk has requested districts that wish to specify how their tax extension should be reduced, forward an appropriate resolution with their tax levy. The attached resolution instructs the County Clerk how our extension should be reduced.

RESOLUTION TO INSTRUCT COUNTY CLERK HOW TO APPORTION 2008 TAX LEVY EXTENSION REDUCTIONS FOR NORTHFIELD TOWNSHIP HIGH SCHOOL DISTRICT NO. 225 COOK COUNTY, ILLINOIS

WHEREAS, pursuant to the limiting rate provisions of the *Property Tax Extension Limitation Act* (hereinafter "Act"), the County Clerk of Cook County has notified this Board of Education that reductions will be made to the 2008 property tax extensions for the School District's 2008 tax levies; and

WHEREAS, the Act provides that the County Clerk is to make extension reductions proportionately among the School District's funds unless otherwise requested by the School District; and

WHEREAS, this Board of Education desires that the tax extension reductions mandated by the Act be apportioned among its funds in a manner, which is not proportional among all funds:

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Northfield Township High School District #225, Cook County, Illinois, as follows:

Section 1. The County Clerk is hereby directed that the following funds shall be limited but that the extensions for said funds shall be no less than as follows:

Operations & Maintenance	\$1,500,000
Transportation	\$500,000
IMRF	\$750,000
Social Security	\$750,000
Working Cash	\$962,500

<u>Section2.</u> The County Clerk is hereby directed that in the event the District's extensions must be reduced below the amounts indicated in Section 1, the County Clerk should reduce the extensions for the education fund.

Section 3. The President and Secretary of this Board of Education are hereby authorized and directed to file the certified copy of this Resolution with the County Clerk.

Section 4. This Resolution takes effect upon its adoption. ADOPTED this 8th day of December, 2008, by the following roll call vote:
