**RE: APPROVAL OF A RESOLUTION AUTHORIZING PERMANENT
INTER-FUND TRANSFERS FOR DEBT SERVICE AND CAPITAL
PROJECTS PURPOSES**

It is recommended that the Board of Education:

Approve a resolution authorizing the transfer of fund balance from the Operations and Maintenance Fund to the Debt Service and Capital Projects Funds.

Background

Pursuant to regulatory changes in the Illinois Administrative Code (23 Ill. Administrative Code 100.50(d)), effective July 1, 2008, the Illinois State Board of Education requires that, (1) when revenues or other sources of funds are pledged to pay debt service on any long-term debt, the moneys shall be transferred into the Debt Service Fund, and (2) when revenues or other sources of funds are pledged to pay for a capital project or acquisition, the moneys shall be transferred into the Capital Project Fund.

The FY2015-16 budget contains expenses for lease certificates totaling \$374,394 (non-operating), and annual expenditures for building projects totaling \$3,250,000 (non-operating). Funding for these expenses for non-levied debt and building projects was previously budgeted directly from the Operations and Maintenance Fund, thereby reducing available fund balance.

However, accounting changes contained in the Illinois Program Accounting Manual require that funding for these pledged expenditures be provided through transfers from the Operations and Maintenance Fund, (operating) to the Debt Service Fund and/or the Capital Projects Fund, (non-operating). The purpose of these transfers is to properly record expenditures and reflect correct balances in each fund. Therefore, for FY2015-16, these expenditures are budgeted in the Debt Service Fund and Capital Project Fund respectively. The funding source for these expenses is a budgeted transfer from the Operations and Maintenance Fund, which requires Board approval through resolution.

**RESOLUTION AUTHORIZING
PERMANENT INTER-FUND TRANSFERS FOR
DEBT SERVICE AND CAPITAL PROJECTS PURPOSES**

WHEREAS, by regulation (23 Ill. Administrative Code 100.50(d)), the Illinois State Board of Education requires that, (1) when revenues or other sources of funds are pledged to pay debt service on any long-term debt, the moneys shall be transferred into the Debt Service Fund, and (2) when revenues or other sources of funds are pledged to pay for a capital project or acquisition, the moneys shall be transferred into the Capital Project Fund.

WHEREAS, the Board wishes to authorize expenditures to pay for debt service and for capital projects using revenues from the Operations and Maintenance Fund;

NOW, THEREFORE, Be It Resolved by the Board of Education of Northfield Township High School District No. 225, Cook County, Illinois, as follows:

1. The School District Treasurer is authorized and directed to permanently transfer from the Operations and Maintenance Fund to the Debt Service Fund the sum of Three Hundred Seventy-four Thousand Three Hundred Ninety-four Dollars (\$374,394), to be used for debt service obligations of the District.

2. The School District Treasurer is authorized and directed to permanently transfer from the Operations and Maintenance Fund to the Capital Projects Fund the sum of Three million Two Hundred Fifty Thousand Dollars (\$3,250,000), to be used for District capital project expenditures as authorized by this Board.

3. This resolution shall take effect upon its adoption.
