RE: Approval of Tax Levy for Tax Year 2013

Special Note

Prior to the adoption of the 2013 Tax Levy, the President of the Board of Education will conduct a public hearing on the proposed tax levy in compliance with the requirements outlined in the Truth in Taxation Act. In accordance with the provisions of the Act, and due to the fact that the levy increase is less than 105% of the preceding year's extension, no public hearing is required for the 2013 Tax Levy. Although not legally required, the Board of Education has determined that it is in the best interest of the community to conduct a public hearing and welcomes public comment.

RESOLUTION OF NORTHFIELD TOWNSHIP HIGH SCHOOL DISTRICT #225, COOK COUNTY, ILLINOIS PROVIDING FOR THE LEVY OF TAXES FOR THE YEAR 2013

WHEREAS, the Board of Education of Northfield Township High School District #225, Cook County, Illinois, has heretofore adopted a budget resolution for said District for the fiscal year commencing July 1, 2013 and ending June 30, 2014; and

WHEREAS, it is necessary for this Board of Education to ascertain how much money must be raised by a special tax for the calendar 2013 year for educational purposes, for operations, building and maintenance purposes, for transportation purposes, for municipal retirement purposes, for social security purposes, for working cash fund purposes, and file a certificate as to such amount with the County Clerk of Cook County, Illinois.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of Northfield Township High School District Number #225, Cook County, Illinois, that there be and there is levied on the equalized assessed valuation of the taxable property of said District for the calendar year 2013 a special tax of \$89,700,569 for educational purposes, \$4,000,000 for operations, building and maintenance purposes, \$250,000 for transportation purposes, \$1,000,000 for municipal retirement purposes, \$1,800,000 for social security purposes, and \$850,000 or working cash fund purposes.

BE IT FURTHER RESOLVED THAT the President and Secretary of this Board of Education be and they are hereby authorized and directed forthwith to execute and file with the County Clerk of Cook County, Illinois a certificate of tax levy for the calendar year 2013 for a levy of the amounts aforesaid.
