Re: Coaching Positions Request to Increase Participation

Date: October 20, 2015

Recommendation: The administration recommends that the Board approve one assistant coaching position for wrestling and one assistant coaching position in baseball at Glenbrook South and Glenbrook North should participation levels be sufficient.

At the May 18 board meeting, the administration provided an in-depth update on student participation numbers in activities and athletics. During that discussion, the administration shared that the two athletic directors expressed a need for an additional assistant coach in baseball and wrestling, which they thought would increase the number of athletes who could participate as well as improve the quality of instruction they would receive. It will also address safety concerns by increasing supervision in wrestling.

This request was outlined by Steve Rockrohr in an e-mail on May 11 which I have attached for your review. Although Steve's comments are more clearly directed at the GBS condition, I have discussed the need with John Catalano at GBN and the same conditions exist with their wrestling and baseball programs.

Since differential positions are negotiated as part of the GEA contract, it was necessary to meet with the GEA leadership regarding the proposed positions. I met with the GEA on September 18 and we discussed compensation for the proposed positions as well as the condition that they would depend on the number of participants who would try out for the sport. The GEA was supportive of the positions and had no concerns with the proposed compensation.

In accordance with the GEA contract, assistant coaches in baseball and wrestling are compensated at Category IV and according to their experience level from Step 1 to 8. **These positions will range from \$5,700 to \$9,456 depending on the people who are hired, which makes the overall cost range from \$22,800 to \$37,824 should all four positions be hired.** I have attached Appendix F of the GEA contract for your review.

The athletic directors have been told that should this recommendation be approved, participation numbers must be sufficient to warrant an additional coach. Coaches who are hired for these positions will not be compensated if student participation numbers are not sufficient. A determination will be made each year on the viability of these coaching positions based on participation numbers.

Mike,

Below is the rational and reasoning to add coaches for the wrestling and baseball programs. Please let me know if you need anything else from John and I. Thanks for the help and of course we will be there to answer any questions on the 18th.

Reasons for consideration a fifth coach for the wrestling program:

- Increases the safety for wrestlers
 - · Allows coaches more time work with each athlete
 - Allows coaches to be at the mat for each wrestler in tournaments (3 weeks out of the year we have a Varsity, JV, Sophomore, and Freshmen meet - meaning that 3 of the 4 levels only has one coach, during a tournament you have multiple wrestlers wrestling at the same time)
 - 2 times in the last 3 years we had to send a parent (not the athlete's parent) with an injured athlete to the hospital so the coach could stay with the team
 - We would be able to split up the practice and not leave a level with only one coach, allowing for more wrestlers to be coached
- · Increases wrestlers opportunities to stick with the sport
 - Not only is enrollment growing, but our sport has been growing as well and we do not cut in wrestling
 - Our feeder program is also starting to develop more wrestlers. Currently there is 7 eighth graders and 6 seventh graders that will be entering GBS in the next few years. When you have a program that has wrestlers with some experience they tend to recruit more wrestlers.

Reasons for consideration a sixth coach for the baseball program:

• Safety and Supervision-Currently the Sophomore team does not have an assistant coach. During practice time, it becomes very difficult to supervise a practice. To maintain an efficient practice (within the 1.5 hour facility space scheduled) hitting, pitching, and defense play have to go on at the same time. One coach has a difficult time supervising this type of practice safely. The actual coaching of skill can be almost impossible. During game play, one coach coaches in the 3rd base box while a student coaches in the first base box. There is no adult in the dugout for over 20 athletes.

• Do our student/athletes get coached? It has become very difficult with space and facilities as our spring sports continue to grow. With one coach for over 20-25 athletes, the coaching of individual game play skill has become very difficult. Organizing a practice and supervising it has to be the priority.
