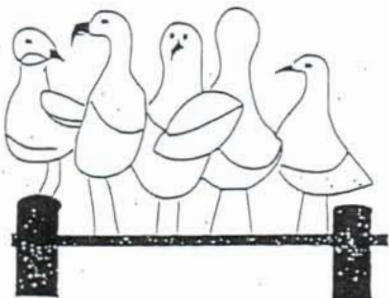

Dean Evans Lecture Series Sponsored by Gibraltar Design

H. Dean Evans served the children of the State of Indiana for over 45 years. His passion for learning changed the lives of many, many individuals -- both children and adults. In recent years, Dean served as Chairman of the Board and Education Consultant for Gibraltar Design, an architectural and engineering firm serving Indiana and Illinois. He was a teacher, principal, and Superintendent of Schools for the MSD of Washington Township in Marion County. In 1985, Dean was appointed by the late Governor Orr as the Indiana State Superintendent of Public Instruction and Chairman of the State Board of Education through 1988. He was appointed to a second term from 1988 to 1992. Dean also served as the Senior Program Officer and Director of Elementary-Secondary Education Programs at Lilly Endowment and on President George H.W. Bush's Educational Policy Advisory Committee.

"Next Generation Schools: What Changes Are Needed to Make American Schools More Competitive" - Dr. Tom Lasley, Dean, School of Education and Allied Professions – University of Dayton

Synopsis - The next generation of schools in the U.S. needs to be more data driven and less focused on seat time requirements such as Carnegie units. It is also imperative that the personnel who provide leadership within the classroom and at the school level better represent the academic elite. How do we get the schools we need? How do we get the right people to provide classroom and school leadership?

Bio - Thomas J. Lasley II is Dean, School of Education and allied Professions at the University of Dayton. He has published in excess of 70 articles in professional journals and has authored or co-authored 11 books. He has served on a variety of regional and state level education commissions and boards including the Governor's Commission on Teaching Success and the Ohio Board of Regents' Planning and Accountability Committee. He founded the Dayton Early College Academy, a unique educational partnership between the University of Dayton and the Dayton Public Schools and is co-chair of the Teacher Quality Partnership.

Dr. Reeves was named the Brock International Laureate for his contributions to education. He also received the Distinguished Service Award from the National Association of Secondary School Principals and the Parent Choice Award for his writing for children and parents.

Focused Presentations

8:30-9:30 From the Research Perspective “ How Students Learn and Apply New Knowledge” – Dr. Steve Ritter

Synopsis – Advances in understanding how students learn, as well as advances in educational technology, have the promise to revolutionize education. This presentation will focus on basic cognitive processes: perception, memory, generalization and motivation and how they are applied in problem-solving and in developing a deeper, more robust understanding. Dr. Ritter will also discuss how educational technology has the ability to monitor student understanding at a finer grainsize than has ever been previously available. Researchers at Carnegie Mellon, Carnegie Learning and other research labs are developing techniques to understand student learning at the minute-by-minute level, which allows for true formation assessment and differentiated instruction.

Bio - Steve Ritter, Co-Founder & Chief Scientist, Carnegie Learning, has been developing and evaluating educational systems for over 10 years. He earned his Ph.D. in Cognitive Psychology at Carnegie Mellon University in 1992 and helped to found Carnegie Learning in 1998. As a post doctoral associate and research scientist at Carnegie Mellon, Dr. Ritter was instrumental in the development and evaluation of the Cognitive Tutors for mathematics. He is the author of numerous papers on the design, architecture and evaluation of Intelligent Tutoring Systems and served as chairman of the IEEE Learning Technology Standards Committee working groups on tool/agent communication.

Synopsis - Dr. Warren will again provide us with the "back story" on emerging Washington issues, politics, the Obama administration and how this all impacts education and local school districts. This year he will focus on the President, the congress and what the current financial/political environment means for PreK-12, higher education and our nation.

Bio - Dr. David L. Warren became president of the National Association of Independent Colleges and Universities (NAICU) in 1993, after nearly a decade as president of Ohio Wesleyan University. Dr. Warren is widely regarded as one of the most persuasive and influential voices for higher education within Washington, D.C. The recipient of 12 honorary degrees and numerous other academic and civic awards, Dr. Warren has been described as one of the most gifted leaders and creative thinkers in all of American higher education. He has been both a Fulbright Scholar and Rockefeller Fellow at Yale.

As an organization the Midwest Suburban Superintendent's Association supports and develops leaders who can create effective, student centered school cultures. Through quality executive development members realize their potential and increase their value to the students, staff and districts they work with. Individuals nominated to be members of MSSA are exemplary leaders who have the following traits: tend to their vision, are able to turn a vision into goals, mentor others toward leadership positions, exhibit self-knowledge, are able to conceptualize, are able to share values, and are able to build constituencies. Their scholarship, experience and contributions to the profession have shown them to be catalysts for positive change.

A Brief History of the Association

The organization was founded in 1940 with the purpose of "providing opportunities for superintendents of midwestern suburban communities to discuss common challenges in the areas of administration, instruction, personnel compensation policy and other topics deemed appropriate".

The membership is limited to only those nominated by the membership committee from the states of Illinois, Indiana, Iowa, Michigan, Minnesota, Missouri, Ohio and Wisconsin. Members have regularly included U.S. Commissioners of Education, college presidents, college deans, state superintendents, AASA presidents and of course, superintendents from suburban districts of note. Early meetings were held around the Midwest and northern Florida until 1989 when the location of the annual meeting was moved permanently to Marco Island, Florida.

**"Changing Landscape of Funding and Control of Public Education"
– Dr. Julie Underwood, Dean, School of Education, University of Wisconsin**

Synopsis- Dr. Underwood will talk about the challenge of funding schools across the United States and how certain pressure groups are attempting to change the school's agenda and direction.

Bio – Julie Underwood, a nationally recognized authority on school law, became the Dean of the UW-Madison School of Education in August 2005.

Dr. Underwood taught at UW-Madison from 1986 to 1995 on the faculty of the Department of Educational Administration. She served as Dean of Miami University's School of Education and Allied Professions and from 1998 to 2005 as Associate Executive Director and General Counsel for the National School Boards Association in Washington, D.C. At the NSBA, she led a legal advocacy program on behalf of the nation's public school boards, including producing friend-of-the-court briefs and legal strategies before the U.S. Supreme Court and lower courts. She also was responsible for the 3,000-member Council of School Attorneys.

During the first half of 2009, she served as UW-Madison's Interim Provost. She has co-authored several books, including School Law for Teachers (Prentice Hall, 2005), Legal Aspects of Special Education and Pupil Services (Boston: Allyn & Bacon, 1994), and The Principal's Legal Handbook (Education Law Association, 1993).

From the State Perspective “The Role of the State Superintendent and How It Has Evolved” – Chris Nicaastro, State Superintendent of Missouri and Deb Delisle, State Superintendent of Ohio

Synopsis – The role of State Superintendent has changed significantly over the past 10 years. Both of the MSSA members on our panel were experienced highly regarded suburban superintendents prior to being hired as State Superintendents. 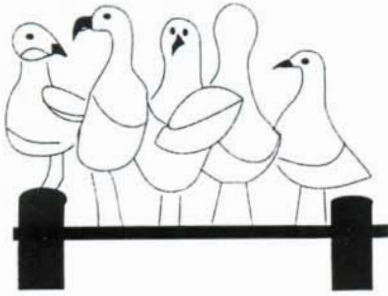

Dr. James Garbarino: The Maude C. Clarke Chair in Humanistic Psychology at Loyola University of Chicago

Synopsis – Professionals and parents are paying increasing attention to the need for "anti-bullying programs" in American schools. Yet, the larger issue is creating and maintaining schools that are "emotionally safe". This commits the school to creating a social climate in which bullying, harassment, and emotional violence are inconsistent with the day-to-day norms of students, faculty, staff, and parents. This is made all the more challenging because of the "social toxicity" of contemporary American life. This presentation outlines an ecological perspective on child development and mental health, and shows how this way of looking at child and adolescent development leads to a focus on character education, structures of adult influence, and habits of peer group behavior. All this can improve the social climate both on site in the school and online in the virtual world of today's youth.

Bio – Dr. James Garbarino holds the Maude C. Clarke Chair in Humanistic Psychology and was founding Director of the Center for the Human Rights of Children at Loyola University Chicago. Previously, he was Elizabeth Lee Vincent Professor of Human Development and the Co-Director of the Family Life Development Center at Cornell University. He earned his B.A. from St. Lawrence University in 1968, and his Ph.D. in Human Development and Family Studies from Cornell University in 1973. He is a Fellow of the American Psychological Association. Dr. Garbarino has served as consultant or advisor to a wide range of organizations, including the National Committee to Prevent Child Abuse, the National Institute for Mental Health, the American Medical

Association, the National Black Child Development Institute, the National Science Foundation, the U.S. Advisory Board on Child Abuse and Neglect, and the FBI. In 1991, he undertook missions for UNICEF to assess the impact of the Gulf War upon children in Iraq, and has served as a consultant for programs serving Vietnamese, Bosnian and Croatian child refugees.

Dr. Garbarino serves as a consultant to television, magazine, and newspaper reports on children and families, and he received the Silver Award at the International Film and Television Festival of New York for co-authoring "Don't Get Stuck There: A Film on Adolescent Abuse". He also serves as a scientific expert witness in criminal and civil cases involving issues of violence and children.

Synopsis – We are nearing the 100th Anniversary of Lincoln's second Inauguration as President (March 4, 1865). It began in a driving rain that filled Washington's famously muddy streets – women would wear the mud caked to their long dresses throughout the day's ceremonies. Walt Whitman saw Lincoln's carriage dash through the rain "on sharp trot" from the White House to the Capitol, scene of the swearing-in. When Lincoln finally stood before his countrymen on March 4th and had only 703 words to share, the American public was stunned. The President did not deliver a victory speech nor excoriate the South. Instead, he deemed the whole country guilty for the sin of slavery. Lincoln's second Inaugural is considered one of the greatest speeches ever given. Dr. Price will share the significant elements of the speech and its lessons for leaders.
