If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days after the date of the denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original request for documents and the denial letter when filing a Request for Review with the PAC. You also have the right to seek judicial review of your denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11.

During the spring 2012, the district received a grant for retro-commissioning services at GBN and GBS. The value of the grant was \$50,000 per school.

Retro-commissioning seeks to identify and correct building energy systems that become misadjusted over time or have failed in ways and are not immediately detectable. Under the program, each building has committed to invest at least \$10,000 in measures that have been identified to have a payback of less than 18 months. This commitment has been met.

GBN – At Glenbrook North, the following measures have been identified and all have either been completed or are in process and will be completed within the next two months. Total cost to implement the measures is \$31,300. Energy savings is estimated to be \$69,515 with an estimated payback of 5 months.
