I recommend the Board of Education grant permission to rehire the non-tenured certified staff members listed as such on the attached spreadsheet. These individuals represent non-tenured certified staff members who would normally be released at this time. However, the building principals have confirmed that student enrollment, academic program needs and the individual's quality performance justify their re-employment. They will each be rehired as a 1.0 FTE. Please note that certified staff members being rehired after a fourth consecutive year of full-time employment will be granted tenure.

I recommend the Board of Education adopt the attached resolution to release the non-tenured certified staff members listed as such on the attached spreadsheet. This list was prepared in consultation with the building principals and has received their approval.

Some of the certified staff members being released at this time may be reemployed after more enrollment information is gathered and reviewed in the coming weeks.

Following the Board Meeting on March 23, 2015, certified staff members being released will meet with their building principals to receive the letter of release. In addition, the letter will be mailed home via certified mail.
