Re: Procedures for Release of Non-Tenured Teachers

At the Board of Education meeting of March 21, 2011, we will ask the Board to adopt the attached resolutions releasing some of our nontenured teachers and part-time teachers. Nontenured teachers must be released at least 45 days before the end of the school year, June 10, 2011. If we fail to release such teachers within this time frame, the teachers are automatically reemployed for the following school year.

According to Illinois School Code, teachers who have been hired as full-time teachers after January 1, 1998, must complete four full-time, consecutive years of employment before they can be granted tenure. At this time, we have sixteen teachers in their first year of full-time nontenure teaching; twenty-three teachers in their second year of full-time nontenure teaching; nineteen teachers in their third year of full-time nontenure teaching; and twenty-one teachers in their fourth year of full-time nontenure teaching.

As we have done for the past several years, we will be requesting permission from the Board to offer contracts to those nontenured and part-time teachers who we are already certain we have positions for and whom we want to rehire. Consequently, we will not include these people in the release process.

It is likely that some of the teachers who will be released March 21st will be re-employed after we have more information later this spring. The additional information involves such issues as the return of teachers from leave, the availability of firm departmental registrations, and the completion of our assessments of several of the teachers.

Following the Board meeting of March 21, 2011, the teachers who are to be released will meet with their principals and be given a copy of the letter of release. In addition, the letter will be mailed to the teacher's home via certified mail.

A summary of the categories of teachers and the Board action to be taken is indicated on the next page.

PART-TIME TEACHERS

There are twenty-three teachers in this category. Historically we have been advised by our attorneys that the Board need not release part-time teachers. However, it is appropriate to release these teachers in order to allow student registrations to be completed thus determining the level of part-time staff required. The resolution to be adopted by the Board and the letter to be sent to these teachers are identical to those for first through third year teachers. The Board is not required to give part-time teachers reasons for their release. On March 21st we will be requesting the Board give permission for contracts to be issued to those teachers we are sure we wish to rehire.

FIRST YEAR FULL-TIME TEACHERS

There are sixteen teachers in this category. We will be requesting the Board give permission for contracts to be issued to most of these teachers. The remaining teachers must be released or they will be automatically re-employed for the 2011-12 school year. The Board is not required to give first year teachers reasons for their release.

SECOND YEAR FULL-TIME TEACHERS

There are twenty-three teachers in this category. We will be requesting the Board give permission for contracts to be issued to most of these teachers. The remaining teachers must be released or they will be automatically re-employed for the 2011-12 school year. The Board is not required to give second year teachers reasons for their release.

THIRD YEAR FULL-TIME TEACHERS

There are nineteen teachers in this category. We will be requesting the Board give permission for contracts to be issued to most of these teachers. The remaining teachers must be released or they will be automatically re-employed for the 2011-12 school year. The Board is not required to give third year teachers reasons for their release.

FOURTH YEAR FULL-TIME TEACHERS

There are twenty-one teachers in this category, all of whom are eligible for tenure. We will forward tenure recommendations to the Board at its March 21st meeting.
