INTERVENTION IN PROPERTY TAX ASSESSMENT PROCEEDINGS

It is recommended that the Board of Education

Approve the Resolution Authorizing Intervention in Property Tax Assessment Proceedings, per the attached.

Background

Glenbrook High School District 225, in cooperation with the elementary school districts in Northfield Township, has taken a proactive stance with regards to interceding in commercial requests for assessment reductions. Each year the district is required to reauthorize our legal representatives to represent the Board of Education's interest in such appeals.

Requests for assessment reductions by commercial property have two major impacts on the district. First, reductions in commercial assessments increase the percentage of taxes for individual resident taxpayers. Secondly, since refunds are taken from the current year tax distributions they cannot be recouped. Consequently, if reduction is granted, tax dollars are lost for the year in which the reduction takes place.

The attached resolution authorizes our legal representatives to intervene in new and pending cases, including those cases that may be presently in the circuit court, dating back to tax year 2002. Approval of this resolution allows intervention into any and all applicable tax assessment proceedings.

RESOLUTION AUTHORIZING INTERVENTION IN PROPERTY TAX ASSESSMENT PROCEEDINGS

WHEREAS, an owner or owners of certain parcels of real property located within the corporate boundaries of Glenbrook School District No. 225, Cook County, Illinois, have filed or are anticipated to file appeals of the assessment of real property for tax years 2002 and succeeding years by the township assessor with the Cook County Board of Review or by the Board of Review of Cook County with the State of Illinois Property Tax Appeal Board ("PTAB") or the Cook County Circuit Court; and

WHEREAS, at least some of these appeals will seek changes in the assessed valuation of parcels in excess of \$100,000; and

WHEREAS, the Board of Education wishes to intervene in any tax assessment proceedings before the Board of Review, PTAB, or the Circuit Court for tax year 2002 and succeeding years whether or not the Board of Education received notice in order to protect its revenue interest in the assessed valuation of the subject parcels set by the township assessor or Board of Review of Cook County;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of Glenbrook School District No. 225, Cook County, Illinois as follows:

Section 1: The Board hereby finds that all the recitals contained above are true and correct, and that the same are hereby incorporated herein by reference.

Section 2: The Board hereby authorizes the law firm of Sraga Hauser, LLC, as its legal representative to: (1) file Requests to Intervene with the Cook County Board of Review, the PTAB, or the Circuit Court with respect to any appeal filed by any and all parties for tax year 2002 and succeeding years relative to any property located within the corporate boundaries of the School District in Cook County, Illinois, for which a tax appeal is pending; and (2) represent the Board's interests in that proceeding.

Section 3: All motions and resolutions or parts thereof in conflict with the provisions of

this Resolution are, to the extent of such conflict, hereby repealed.

If any section, paragraph, clause or provision of this Resolution shall be held **Section 4:** invalid, the invalidity of such section, paragraph, clause or provisions shall not affect any of the other sections, paragraphs, clauses or provisions of this Resolution.

Section 5: This Resolution shall be in full force and effect upon its adoption and shall remain in effect until action by this Board to modify or rescind it.
