Infosnap is an online, hosted solution for enrollment and registration services that provides secure, customizable forms for families to complete online. Presently, enrollment and registration services are done through various paper forms completed via school visits, mailings, and book sale during the summer. The features of Infosnap allow us to create a paperless, more reliable process using the following features:

- integration into our current SIS providing parents access through the PowerSchool parent portal
- digitized fields and forms
- scan and upload documents by parents
- collection of online payments and fees
- electronic signatures
- customized print templates for student files
- customized screens and language
- secure, encrypted transmission housed on infosnap servers at rackspace®

By shifting to a digital solution, there are several key benefits:

- student and parent data is cleaner and more consistent
- parents access to update information is simplified via the PowerSchool portal
- book sale and student services efficiency is increased
- mailings and staffing costs are decreased
- forms and documents are centralized






